Dear Governor Wolf,

Under your leadership, historic levels of education funding have been reinvested into our public schools. For far too long, our children suffered year after year from catastrophic budget cuts that resulted in the layoffs of nurses, counselors, reduced staffing, and criminally under-resourced schools. Alongside you, we have been fighting relentlessly to ensure that all of our students across the Commonwealth have the resources they need and deserve.

Today, we write to you as members and supporters of the Fund Our Facilities Coalition, a group of elected officials, labor leaders, and community groups united in its demands for immediate investment in the school infrastructure remediations that our buildings so desperately need. As you likely know, our coalition officially launched in March 2019 as an effort to coalesce around identifying the urgent resources needed to ensure the safety of our children and educators. For years, many of us have been engaged in this work and have been sounding the alarm about the catastrophic conditions in which our children learn.

As you know, our Coalition has calculated that for \$170 million, we could remediate the most pressing environmental hazards in Philadelphia's school buildings. This figure was devised after your very welcome investment of nearly \$8 million (matched by the District) in lead remediation in the summer of 2018. It was, however, devised before

your recent investment of more than \$4 million this summer, leaving us just shy of \$166 million to be funded.

Recently, we have called for an even more drilled down figure--\$100 million. In light of the horrific Mesothelioma diagnosis of a long-time Philadelphia teacher, we once again made our urgent plea. We believe that \$100 million of our \$170 million ask must be invested immediately to address dangerous asbestos and lead in each school.

We write to you today to urge you to explore every option to address this truly catastrophic health crisis. Attached are some recent photos collected by the PFT Environmental Scientist and/or submitted to the Philadelphia Federation of Teachers' Healthy Schools App. They merely scratch the surface of what our children and educators are enduring. Our school tour series is underway, and we welcome your participation in any of our upcoming tours, many of which are to be scheduled.

The time for action is now. This cannot wait another year, nor another month.

We believe that there are myriad ways to find the money for an emergency of this magnitude. We look forward to hearing from you, and we thank you for the efforts you have made for our young people and educators across the Commonwealth.







The Coalition has calculated that for \$170 Million, we could remediate the most pressing environmental hazards in Philadelphia's school buildings. This figure was devised after your very welcome investment of nearly \$8 Million (matched by the District) in lead remediation in the summer of 2018. It was, however, devised before your recent investment of more than \$4 million this summer, leaving just shy of \$166 million to be funded.

Recently, the Coalition has called for a reduced figure--\$100 Million. Considering the horrific Mesothelioma diagnosis of a long-time Philadelphia teacher, there is little time for delay. Two additional schools in Philadelphia have been temporarily closed due to known asbestos in the facility. The requested \$100 million must be invested immediately to address dangerous asbestos and lead in each school.

Attached are some recent photos submitted to the Philadelphia Federation of Teachers' Healthy Schools App. They merely scratch the surface of what our children and educators are enduring. I have personally walked through one school and have seen the aging building and hazardous environment. Our school tour series is underway, and I welcome your participation in any of our upcoming tours, many of which are to be scheduled.
